Terms and Conditions Win Your Purchase Amount Back

These terms and conditions apply to the contest "Win Your Purchase Amount Back," which is mentioned on the website https://www.motorbeursutrecht.nl/aankoopbedrag-terugwinnen, hereinafter referred to as the "Contest." The Contest is organized by Jaarbeurs B.V., located at Jaarbeursplein 6, 3521 AL Utrecht, hereinafter referred to as the "Organizer." The provisions laid down in the 2014 Promotional Games of Chance Code of Conduct apply to the Contest.

During MOTORbeurs Utrecht 2025, which runs from February 20 to February 23, 2025 (hereinafter referred to as the "Event"), you can win prizes by purchasing a motorcycle present at the Event. The purchase agreement must be signed at the Event. Any person may participate in the Contest, hereinafter referred to as the "Participant(s)," subject to these terms and conditions. Winners (hereinafter referred to as "Winner(s)") will be chosen from the Participants by the Organizer.

Participants must send an email to motorbeurs@jaarbeurs.nl including their name, phone number, the brand, type, and description of the motorcycle, and the booth where the motorcycle was purchased. Additionally, a copy of the signed purchase agreement and a photo of the motorcycle (with the license plate clearly visible) from the Event must be submitted. This Contest is made possible by the Organizer, Combi Motors Verzekeringen B.V. (hereinafter referred to as "Combimotors Verzekeringen"), MotoPlus (hereinafter referred to as "MotoPlus"), and MOTORKLEDINGSTORE.nl.

Article 1 Participation

- 1. To participate in the Contest, you must: (i) Be at least 18 years old; (ii) Present a valid purchase agreement for a motorcycle signed at the Event to the Organizer; (iii) Submit a photo clearly showing the motorcycle present at MOTORbeurs Utrecht 2025 with a readable license plate; (iv) Provide accurate contact details to the Organizer as described above.
- 2. Participation in the Contest is free of charge.

Article 2 Communication Costs

No communication costs are associated with the Contest.

Article 3 Prizes

- 2. Participants guarantee to the Organizer that all information provided during the Contest is accurate, up-to-date, and complete.
- 3. By participating, the Organizer and prize sponsors may use submitted visuals for promotional purposes (e.g., mentioning the Participant's name and photo in press releases, newsletters, photos, videos, and social media).
- 4. The Winner's name will be published in all media channels managed by the Organizer (including Facebook, Instagram, LinkedIn, newsletters, and the MOTORbeurs Utrecht website).

5. All data provided to the Organizer will be processed per the Organizer's privacy statement, accessible at www.jaarbeurs.nl/privacystatement.

Article 6 Organizer's Rights

- The Organizer reserves the right to disqualify any Participant and/or exclude them from participation if they violate these terms and conditions or act unlawfully towards the Organizer and/or third parties.
- 2. The Organizer reserves the right to terminate, interrupt, or modify the Contest and/or its terms and conditions and/or the prize without prior notice if circumstances require it, without being liable for damages to Participants.
- 3. The outcome of the Contest is not open for discussion. In case of disputes between a Participant and the Organizer, the Organizer's decision is final.

Article 7 Liability

- 1. Despite the Organizer's best efforts to manage the website and the Contest, provided information may be incomplete or incorrect. Printing, spelling, or similar errors in published material cannot be held against the Organizer.
- 2. The Organizer is not liable for any damages arising from or related to participation in the Contest.
- 3. The Organizer is not responsible or liable for any costs incurred by Participants in connection with their participation in the Contest.
- Participants indemnify the Organizer against third-party claims related to noncompliance with these terms and conditions and/or related to their actions or omissions.

Article 8 Gambling Tax

The gambling tax on the prizes will be paid by the Organizer.

Article 9 Complaints

Complaints about these terms and conditions, the prizes, or anything arising from them can be submitted to the Organizer within four (4) weeks after the Contest ends. The Organizer will make every effort to resolve complaints as quickly as reasonably possible.

Article 10 Miscellaneous

- 1. If one or more provisions of these terms and conditions are nullified or void, the Organizer will establish a replacement provision that approximates the intent of the nullified or void provision as closely as possible and is not nullifiable or void.
- 2. These terms are governed by Dutch law. Disputes will be submitted to the competent court in Utrecht.
